Special Section: Developing a Social and Economic Justice Agenda for Gerontological Social Work that Reduces Discrimination and Disparities Related to Race, Ethnic, Immigrant, and Indigenous Status

AGESW announces a special section of the *Journal of Gerontological Social Work (JGSW)* focused on dismantling institutional racism with specific consideration of issues of aging and social work with older adults and their families. The aim of this issue is to provide space for voices from practice, research, and policy to discuss where the field of gerontological social work currently is, and where it needs to go, in order to actively engage with and reduce negative experiences and outcomes based on skin color, country of origin, and history of colonialism.

AGESW will select a paper from this issue for the AGESW Social Justice Award and a prize of \$500 USD.

JGSW invites submissions that identify elements of a social and economic justice agenda for education, practice, research, and policy. Authors are encouraged to go beyond discussion to focus on action. We request authors to identify at least one element for a social and economic justice agenda in their submission. Example areas of submissions include criminal justice reform, civic disenfranchisement, health disparities, housing bias, social exclusion, intersectionality, income and asset inequality, and discrimination in formal service provision, among other areas. Manuscripts may be submitted as letters to the editor, commentaries, brief reports, research manuscripts, conceptual or theoretical analysis, policy analysis or knowledge translation study/activity.
