#### **UNITE to End Structural Racism in Biomedical Research**

On behalf of the National Institute on Aging, I stand with [NIH Director Dr. Francis S. Collins](#) in strong support of UNITE, a new initiative to end structural racism in biomedical research at NIH, in our grantee institutions, and beyond.

### **Examining and Addressing COVID-19 Racial Disparities in Detroit**

**Tuesday, March 2, 2021 1:00 PM - 2:00 PM EST**

COVID-19 has disproportionately impacted Black communities. In fact, Black Americans are 2.3 times more likely than white Americans to die from the virus. Black residents of Detroit, Mich., have been hit especially hard. In Detroit, Black people represent 76% of known COVID-19 diagnoses by race and 87% of deaths. Considering the sizable percentage of missing data, the Black community may have suffered even more.


In a forthcoming paper entitled "Examining and addressing COVID-19 racial disparities in Detroit," Brookings Rubenstein Fellow Rashawn Ray, Jane Fran Morgan, Lydia Wileden, Samantha Elizondo, and Destiny Wiley-Yancy address the staggeringly large racial gap in COVID-19 infections in the city. The research finds that in addition to being disproportionately more likely to contract and die from COVID-19, Black residents in Detroit also experience financial, employment, and housing stressors, all of which have been exacerbated by the pandemic.

On March 2, the Race, Prosperity, and Inclusion Initiative at Brookings will host a webinar to discuss COVID-19 racial disparities in Detroit and the findings of the paper. Speakers will discuss the structural conditions contributing to the racial gap in COVID-19 infections among Black and other communities of color and policy recommendations to address these inequalities.

### **Dr. James S. Jackson Seminar on Health Equity and Alzheimer's Disease**

**Wednesday, March 3, 2021, 5:00 – 6:30pm**



Older Black/African-Americans are about twice as likely to have Alzheimer's or other dementias as older whites, and Hispanic/Latinos are about one and one-half times as likely to have Alzheimer's or other dementias as older whites. Health equity can be achieved when people have resources to protect their health and well-being. However, social determinants of health can lead to differences in the access of quality of care, access to treatment, and higher rates of disease and death for these and other populations. The COVID-19 pandemic and its subsequent vaccine rollout have shined an even brighter light on the need for more work to be done across the public health spectrum. Join us as we talk with some of the nation's leading scientists and experts as they discuss the latest in health equity research focused on Alzheimer's and other dementia. Alzheimer's
